This month we are pleased to have Butch Kirven and Jason Miller join us for our GCRW luncheon on March 22.

Mr. Kirven's position as chairman of the Greenville County Council provides him with an opportunity to make a significant impact on our everyday life. However, it also makes him a magnet for controversy and criticism. For example, you have no doubt heard about the issues related to development along Woodruff Road. Fortunately, Mr. Kirven is a leader with a proven background. He graduated from Presbyterian College, and he served as a brigadier general in the Army National Guard.

The Greenville County Council is instrumental in our economic growth and is responsible for building a strong infrastructure for our county, broadening our tax base and enhancing our quality of life. As Greenville continues to grow, the challenges facing the county and County Council grow exponentially in both number and complexity. Mr. Kirven's topic for our luncheon will be "Republican Principles in a Dynamic Economy."

Our other speaker, Jason Miller, is the deputy chief of staff for Coalitions and Strategic Planning in the Governor's Office. As Gov. Mr. Miller will speak to us on the continued efforts by the governor to restructure our state government. As we move further into Gov. Sanford's second term, the importance of pushing his agenda for the reform of South Carolina's government requires all of us to become more active in supporting him.

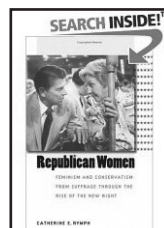

2006 Legislative Day with Gov. Mark Sanford

Gov. Sanford calls for removal of grants review proviso: bad for taxpayers

COLUMBIA—Gov. Mark Sanford issued the following statement in a press release March 13 on the S.C. House's budget, including the soon-to-be-debated proviso setting up a new process to award tens of millions of dollars in grants at the state level.

"First off, I'd give real credit to the House for much of what's in their budget document, which to a large degree mirrors what we'd proposed in our own Executive Budget," Gov. Sanford said.

"The House is making a significant step toward shoring up our long-term retiree health care liability, they're cutting income taxes, and they're paying for the unfunded liability in the tuition prepayment program. As well, the House budget limits tuition increases, puts dollars in the Commerce closing fund, puts new Troopers on the roads and funds a down payment on the port access road in North Charleston—all of which are important budget priorities for the state.

"All of that being said, though, we remain very concerned about things like the House's budget proviso regarding awarding millions of dollars in grants through an unaccountable and not at all transparent process.

"Right now, those grants reside at the Budget and Control Board, where a temporary hold has been placed on awarding those grants until an accountable and transparent process is put into place so those grants can truly be awarded competitively, rather than on a 'who knows who' basis preferred by some in the legislature.

"The House proposal is the exact opposite of what we've been pushing for in terms of restructuring, and it creates a real danger of turning this grants process into a legislative favor factory where certain members of the General Assembly would be able to hold sway over tens of millions of dollars and use them for political purposes.

"I'd urge every House member to consider this issue carefully during budget deliberations this week, and to vote against provisos like this one that would undermine much of the good work they've done on this budget."

Immigration bills in General Assembly

The 2007 S.C. General Assembly is putting forth several bills dealing with illegal aliens in South Carolina.

Senate Bill 392, Illegal Immigration Reform Act, is a comprehensive bill that addresses employment screening of valid Social Security numbers, penalties to employers who violate immigration laws, authorization of S.C. law enforcement to uphold and enforce current immigration law, alien screening to access social services, illegal alien screening in our prison system, and a crackdown on illegal aliens who are unlicensed, unregistered and uninsured motorists.

The S.C. House has introduced H-3148, the SC Immigration Compliance Act of 2008.
