# CELEBRATE THE RED, WHITE & BLUE AMERICANISM PROGRAM - JUNE 26 MEETING

On Thursday, June 26, our annual Americanism program will have three special features you will not want to miss.

We are excited to have Lt. Col. Clarence Bowser, a decorated veteran in the War in Afghanistan, joining us, along with Jo Dillard and Dot Bishop, both representing Blue Star Mothers. We will also have a very special presentation of patriotic music sung by Nancee Lee Yearick during the program this year.

Lt. Col. Bowser, a graduate of

Livingstone College in North Carolina, with a Masters Degree in Military Management from Touro University Inter-

national, volunteered to serve as an embedded officer with the Afghan military. He deployed to Kandahar, Afghanistan, in May 2007, a critical area in Southern Afghanistan and a fiercely contested area of the country. Lt. Col. Bowser was responsible for training and mentoring Afghan soldiers fighting the Taliban, and he served as communications officer in the Southern region of Afghanistan.

Lt. Col. Bowser distinguished himself in combat during his tour in Afghanistan, culminating in his receiving numerous awards and citations, including the Bronze Star for his valor.

I know you are familiar with the Blue Star Mothers of America. It is an organization comprised of mothers who either have, or who have had, children honorably serving in the military. Their goal is to support their children, each other, and our country by promoting patriotism. In the Upstate, we are fortunate to have four Blue Star Mother Groups, and there are eight other groups throughout the rest of South Carolina.

Jo Dillard, a Greenville area native and the early education principal at Southside Christian School in Simpsonville, will represent the Blue Star Mothers. She became an active member of the Blue Star Mothers during her son's active duty as an infantryman and his deployment with the U.S. Army in Afghanistan. Jo will give us an insight into her experiences, both as a mother and a member of the Blue Star Mothers.

Dot Bishop is a representative of the Greenville Area Blue Star Mothers, and she will provide us with more information about this wonderful organization. Her son Andrew graduated from Berea High School, Appalachian State University and Widener University, and now serves as a career sol-

dier. He is stationed in Honolulu, Hawii, having previously served in Iraq in 2005-2006.

### South Carolina Republican Party Convention Highlights

Several GCRW members and associate members traveled to Columbia May 31 to represent Greenville County at the South Carolina Republican Party Convention.

Of the 625 total delegates, Greenville County had the largest delegation with 65 voting delegates and seven unseated alternates.

Those members who attended as delegates were **Betty Poe**, **Joanne Meadows**, **Karen Mims**, **Geri Warren**, **Bob Dill**, **Willis Meadows**, **Dennis Jones**, **Samuel Harms**, **Tom Mims**, **Wendy Nanney and Dan Rawls**. **Connie Jones** also attended.

This year's convention delegates had the opportunity to hear from state leaders beginning with our Gov. Mark Sanford.

#### **Legislative Corner**

#### Governor signs immigration bill

Gov. Mark Sanford signed an immigration reform bill June 4 that was passed after tough debate by the S.C. House and



Senate. While the majority of issues surrounding illegal immigration still have to be addressed at the federal level, the new state law creates the following reforms:

- Requires private employers to verify lawful status of all employees by either (1) using E-Verify or (2) requiring S.C. driver's license or equally secure driver's license from another state. The S.C. Department of Labor, Licensing and Regulation (LLR) can impose fines of \$100 to \$1,000 on employers for failing to properly verify the legal status of all employees.
- Prohibits private employers from knowingly and intentionally hiring illegal workers. LLR can suspend imputed S.C. business licenses of employers who violate this provision.
- Requires government contractors to verify employees' work authorization status with E-Verify.
- Authorizes S.C. Law Enforcement Division to enter into an agreement with the U.S. Department of Justice and Homeland Security that allows state and local law enforcement to enforce federal immigration laws.
- Requires state and local agencies to verify lawful presence in the United States of all aliens over the age of 18 who apply for public benefits, with exceptions for emergency medical services, disaster relief, prenatal care, federal college aid, domestic violence and S.C. retirement benefits. Verification is to be made through the federal Systematic Alien Verification for Entitlements (SAVE) program.
- Establishes hotline, web site and database for reporting and tracking alleged violations of immigration laws.
- Prohibits wages paid to illegal workers from being deducted from state income taxes.
  - Requires jails to verify lawful presence of inmates.
- Prohibits local governments from prohibiting law enforcement from enforcing immigration laws. Jamie Bach.

The governor gave a rousing and detailed speech challenging all to "know what we believe" and "to stay true to our principles." He was interrupted by several standing ovations.

Other elected leaders who addressed the convention were U.S. Sens. Lindsey Graham and Jim DeMint; and Reps. Bob Inglis, Joe Wilson and Gresham Barrett.

The state officers who spoke were Lt. Gov. Andre Bauer, Attorney General Henry McMaster, Treasurer Conrad Chellis, Secretary of State Mark Hammond, Comptroller General Richard Eckstrom and Commissioner of Agriculture Hugh Weathers.

All statewide candidates were given a few minutes to speak also. President George Bush and Sen. John McCain sent taped messages to the convention. *Geri Warren*.



#### Delegates Elect Glenn McCall National Committeman

Delegates at the S.C. Republican Party Convention overwhelmingly voted to elect Glenn McCall S.C.'s national committeeman. If you will recall, Glenn was GCRW's featured speaker July 2007
