## THE RACE IS ON . . .

# FOURTH DISTRICT CONGRESSIONAL SEAT

Our speakers for this month are **Rep. Bob Inglis**, Fourth District incumbent, and **Solicitor Trey Gowdy**, who will be challenging him for his seat in the primary election.

Rep. Inglis was first elected to Congress in 1992 and was reelected in 1994 and 1996. In 1999 he returned to the practice of commerical real estate law at the law offices of Leatherwood, Walker, Todd and Mann, PC, until he was re-elected in 2006 and 2008. He serves on the Science & Technology Committee and is ranking member of the Energy and Environment Subcomittee.

He also sits on the Foreign Affairs Committee in the 111th Congress, as he did in the previous Congress. He

chaired the Research Subcommittee of the Science Committee in the 109th Congress and served on the Judiciary Committee and on the Education and Workforce Committee. He co-chairs the House Hydrogen and Fuel Cell Caucus.

Bob will have hosted 10 town hall meetings in August about health care after spending a year doing a health care tour with around 79 stops learning from those in the health care field what they think are the best solutions.

Bob is a 1981 graduate of Duke University and a 1984 graduate of the University of Virginia Law School. He and his wife Mary Anne have five children, ranging in age from 13 to 24.

Bob and his family are members of Redeemer Presbyterian Church in Travelers Rest. He enjoys time with his family on their small farm in northern Greenville County, hiking, whitewater paddling, mountain biking and occasional trips to his hometown of Bluffton, S.C., where he enjoys sailing and waterskiing.

burg, is one of the candidates who will be opposing Rep. Inglis in the next election. Trey graduated from Baylor University with a degree in history in 1986 and from the University of South Carolina School of Law in 1989.

After law school, he clerked for the late John P. Gardner on the South Carolina Court of Appeals and United States District Court Judge G. Ross Anderson Jr. in Anderson, S.C.

He then joined the law firm of Nelson, Mullins, Riley and Scarborough in the Greenville

Office before becoming a federal prosecutor in April

In February 2000 he left the United States Attorney's Office to run for seventh circuit solicitor. He defeated the incumbent solicitor in the Republican primary and was elected in November 2000 without opposition. He has been reelected twice — in 2004 and 2008 — without opposition.

He received the highest performance rating a federal prosecuter can receive — two years in a row.

Trey has been recognized statewide for his commitment to victims rights, drunken driving enforcement and nationally for excellence in death penalty prosecutions. He and his wife Terri have two children.

Ladies, this is a good time to meet the incumbent and to meet one of the challengers.

Please have your questions ready for these two candidates to help make your decision for the coming election.

The remaining three candidates for the Fourth District congressional seat, **Dr. Christina Jeffrey** (a GCRWC associate member), **Jim Lee** and **State Rep. David Thomas**, will be invited to speak at a future meeting. *Kathy Davis*.



The health care reform debate has intensified as members of Congress and Senators returned to their home districts during the August recess.





reform proposals. Opposition at some meetings has been vocal and well publicized, and some mainstream media have characterized these district meetings as being mob-like and orchestrated.

House Speaker Nancy Pelosi derided opponents of health care reform as Astroturf, not representative of true grassroots sentiment. Her characterization of grass roots American anger at the idea of socialized health care would be funny if it were not so ironic. During the presidential campaign, candidate Barack Obama touted his credentials as a community organizer as qualifying him for the presidency. A community organizer is basically someone who organizes people to go to government meetings to push their ideas. Funny how when President Obama does it, liberals swoon, but when conservatives do the same, they seethe.

More galling is the fact that these same Democrats are now pushing their health care agenda through Obama's multimillion dollar Organize America PAC. I guess when ordinary Americans take time off from work to make their own signs and show up at rallies opposing socialized health care, it's Astroturf, but when Democrats use George Soros' money to print focus-group-tested signs and pay staff to organize local unions and Democratic operatives, that's true American dissent.


Our deepest sympathy is extended to the family of GCRWC's faithful and loyal member **Jane Hansley**, who passed away Aug. 7.
